



Rosoff Artworks Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.rosoffartworks.com and Jill Rosoff Artworks and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Jill Rosoff Artworks include www.rosoffartworks.com and USIBD. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, USIBD may collect personally identifiable information, such as your:

- First and Last Name

If you purchase Jill Rosoff Artworks products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
